We are grateful to all who contribute to this place, including those who give financially.

Our income sources are: an endowment fund, some of our events; regular and occasional donations; Gift Aid; contributions from our partner, All Saints' church.

Our principal expenditures are: salaries; grants; electricity & other utilities; office expenses; hospitality, housekeeping & minor maintenance; Health & Safety inspections; insurance.

Our 2020 budget covers expenditure from current income levels. What a blessing to be in this position – thank you!

It would give us confidence in planning and developing our programmes if more income came from regular donations. Currently, our main source of income is the Endowment Fund: at present, it covers salaries and grants. Ticketed events have broken even in recent years. Donations and All Saints' contributions go towards utilities and the cost of free events, which includes worship.
